

Florida Oceanographic Capital Campaign Report BOD 1/25/21

Since our last Board meeting we have increased our Capital Campaign totals:

Total 132 donors - \$7,054,784 committed/pledged, Reef Sculpture 4 donors \$70,000. Endowment - 5 bequest estate gifts totaling \$1,050,000 includes signed \$50k cash 5-yr pledge, a % estate legacy gift and 2 notifications of legacy estate gifts (estimate \$1M).
